They can be amended to meet the needs of your organization over time. Before doing this there a few important points to consider:

- 01. There is only one rule set. If the rule set gets deleted, it is permanently gone and cannot be retrieved. Please ensure you have a detailed record of your requirements and a screenshot you the current rule set before making changes.
- 02. If you are confident and happy with your changes, please remember to save before leaving the rule engine otherwise you will lose your changes.
